Rather, in the analysis of different cases involving Mexico, the perceived conduct of the foreign investor could beused by the host country as a defense in allegations of FET violations. According with this book, this isthe only approach that seeks to find a balancebetween the investors' rights and the legitimatedomestic public policies of the host country. This book analyzes the factual circumstances andlegal allegations marshaled by the parties in thosecases involving Mexico, and highlights the differences in the construction of the FET standardmade by the tribunals in the cases resolved In the NAFTA context, and those settled in the framework of the Bilateral Investment Treaties.
