Nearly 90 percent of the estimated number of violent crimes in the United States occurred in M.S.A.s, 5.7 percent occurred in cities outside M.S.A.s, and 4.5 percent occurred in nonmetropolitan counties. By community type, the violent crime rates were estimated at 489.0 incidents per 100,000 inhabitants in M.S.A.s, 392.0 incidents per 100,000 inhabitants in cities outside M.S.A.s, and 205.1 incidents per 100,000 inhabitants in nonmetropolitan counties. Law enforcement agencies made 14,005,615 arrests, excluding traffic violations, in 2008. Of these arrests, 594,911 w
